

Privacy Statement

Fortis Technologies Ltd. (“we,” “our,” or “Fortis Technologies”) has amended our Privacy Policy (“Privacy Policy”) to disclose our collection, usage, and disclosure practices with respect to personally identifiable information of: (a) visitors (“Visitor”) of this website including prospective customers and/or employees; and (b) end users (“User”) of our products, technical support, and/or services (collectively, “Services”).

Information provided to or collected by Fortis Technologies
